He has been recognized by attorneys across the country as one of the Best Lawyers in America for commercial litigation and is AV-rated by Martindale Hubbell. Mr. Alavi has been consistently recognized on Texas Super Lawyers listing.

He has had key roles in trial wins including:

- Newfield v. Tesoro Mr. Alavi represented Newfield Production Company against
  one of the country's largest refining companies in a breach of contract dispute
  involving crude supply contracts. After a lengthy arbitration, Mr. Alavi helped
  Newfield secure a \$20 million award while successfully defeating in full a
  counterclaim for \$400 million.
- Rembrandt Wireless Technologies, LP v. Samsung Electronics Co. Ltd., et al. —
   Mr. Alavi and a team of attorneys from Heim, Payne & Chorush won a \$15.7
   million patent infringement verdict for Rembrandt Wireless. The jury deliberated
   only one hour before finding that Samsung Electronics infringed two
   Bluetooth patents owned by Rembrandt.
- Saint Lawrence Communications v. Motorola— Mr. Alavi won a \$9 million jury verdict for Saint Lawrence Communications LLC against technology heavyweight Motorola Mobility LLC for patent infringement. The case was tried in the U.S. District Court for the Eastern District of Texas.

### Other Notable Cases

- Versata Software Inc., et al. v. SAP America Inc., et al. Mr. Alavi
  and Demetrios Anaipakos were hired by Versata Software only a few months
  before the retrial of a significant case against SAP America. Despite the time
  crunch, the two attorneys helped Versata win a \$391 million
  patent infringement verdict.
- Houston v. Saracen Energy Advisors, L.P., et al. Represented a natural gas energy trader in claims for \$30 million in bonus and deferred compensation. The case settled on a confidential basis.
- Culliver v. George Bishop, et al. Represented the plaintiff, a shareholder of an independent oil and gas company, in a shareholder oppression case seeking over \$150 million. The case settled on a confidential basis prior to trial.
- Brown Investment Management, L.P. v. Parkcentral Global, L.P. Represented an investor in the Parkcentral hedge fund which, with a related hedge fund, lost over \$2.5 billion. In an important case involving hedge funds, Mr. Alavi











secured a verdict granting his client access to the fund's investor list. The case was appealed to the Delaware Supreme Court and affirmed.

- Mr. Alavi represented the former employee of an independent oil and gas
  exploration company in an arbitration seeking to recover plaintiff's \$60 million
  ownership interest in various oil and gas properties. The case was resolved on
  a confidential basis.
- Tennessee Gas Pipeline Co. v. Columbia Gulf Transmission Co. Represented Columbia Gulf Transmission Co. in a breach of contract lawsuit involving control (and the original construction) of the Blue Water offshore natural gas pipeline system. Following a bench trial, the case was resolved on a confidential basis.
- Marc Werner, et al. v. KPMG, LLP Represented limited partners of an investment partnership in a securities fraud case against KPMG. The case was resolved on a confidential basis.
- Lenore Schmick Trust, et al. v. KPMG, LLP Represented limited partners of an investment partnership in securities fraud case against KPMG. During trial, the case was resolved on a confidential basis.
- Chung's Gourmet Foods v. Delta DailyFoods Texas Represented Chung's
  Gourmet Foods, one of the world's largest manufacturers of egg rolls in a
  tortuous interference case against Delta DailyFoods. After nearly two weeks of
  trial, Mr. Alavi and the trial team obtained a verdict and judgment in the
  amount of nearly \$18 million.
