Justin Chen is an intellectual property lawyer focusing on patent litigation. His degrees in business and electrical and computer engineering inform his work for major manufacturers of semiconductors, smartphones, electronic lighting controls, and other products. He has represented clients in district court cases nationwide, as well as before the International Trade Commission.

Mr. Chen provides experience in all phases of patent litigation, from pre-suit investigations through trials and appeals. He has argued several Markman and summary judgment hearings and matters before the U.S. Court of Appeals for the Federal Circuit.

He has earned multiple rankings on the annual Best Lawyers: Ones to Watch list, a national peer review award recognizing attorneys for outstanding professional excellence early in their careers. Mr. Chen is also a multi-year honoree on the annual Texas Rising Stars list in recognition of his expertise in intellectual property litigation.

The Rising Stars rankings are reserved for attorneys age 40 and younger and those who have been in practice no more than 10 years. Fewer than 2.5 percent of eligible Texas attorneys earn this selection each year.

Before joining Alavi Anaipakos, Mr. Chen worked at the AmLaw 100 firm Vinson & Elkins and the intellectual property boutique Ahmad, Zavitsanos, Anaipakos, Alavi & Mensing.

A graduate of the University of Pennsylvania Law School, Mr. Chen also has a certificate in business and public policy from the Wharton School. He graduated *cum laude* from Rice University, where he studied electrical and computer engineering.

Before law school, Mr. Chen worked as a research assistant at the Rice University Center for Multimedia Communication, where he designed and implemented a spectrum analyzer and memory board for the Wireless Open-Access Research Platform (WARP).
